2. Living man can bargain with anyone; one corporation can only bargain with another corporation; **a corporation/entity and legal/legal fiction cannot impose unilateral acts on a living man**. The claim to unite a living man with juridical fiction has allowed, by deception; a corporative entity to subjugate, through it, a living man; this constitutes PREJUDICE AND DISHONOUR.
3. **A contract to be valid**, must present and meet the essential requirements. If even one of these requirements is missing, the contract does not have its effects and, therefore, the parties are not required to comply with any commitment. The first essential element of a contract is the **agreement**, that is, a proposal, an acceptance, which leads to an agreement; without proposal and without acceptance, which can be explicit or tacit, but free from conditioning or induction, the contract cannot bind anyone. **You cannot make a commitment that you never wanted**. The legal fiction, natural person, created, **by means of the act and the birth certificate, at the coming into the world of the born alive**, is the presumption of incapacity and / or absence of the primary requirement underlying the constitution of the contract. The contract thus born is in fact illegitimate, illegal, therefore **repealed**; **it follows that the deception with which the living man is induced to recognize himself in a NAME SURNAME, natural person, legal fiction, is criminal and fraudulent**.
